

STEAMSHIP TICKET

This prop is a replica of a vintage steamship ticket.

Print first side on heavyweight light pink paper, if possible, like construction paper. (Although don't use actual construction paper if you can find something better.) Reinsert paper into printer and print second side on reverse.

Perforate at dashed lines.

Trim at solid black crop marks.

Stamp a date in the validation squares on the reverse side.

Passenger and trip information should be entered by hand.

Use a hole puncher to punch out the date, and other applicable places where punches are indicated. Many craft and art supply stores sell paper punchers that come in various shapes other than the traditional round hole, if you want to try them. You can also find actual vintage ticket punchers on eBay from time to time.

As you can tell from looking at it, the ticket is designed to be torn apart section by section as the trip continues. The agent who sells the ticket removes the first stub. Another stub is surrendered when boarding the boat for the first time. A third stub is surrendered when disembarking the first boat, etc. By the end of the journey, the only part of the ticket left in the passenger's possession is the main coupon on the upper right.

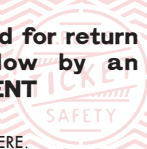
