*A 2-page contract to bind the soul of a mortal to  
the service of an infernal being in the afterlife*

# *Infernal Binding Contract*

*The mortal signee requests the following:*

*In exchange for the infernal being granting the mortal signee's request, the mortal signee agrees to the following:*

- 1. **Infernal Binding.** After death, the soul of the mortal signee shall be bound to the infernal being. While bound in this way, the mortal signee shall be unable to directly harm the infernal being, and the infernal being shall know at all times when the mortal signee is acting against the infernal being's interests.*
- 2. **Sufficient Consideration.** The mortal signee acknowledges that the granting of the mortal signee's request constitutes sufficient consideration to render this contract binding.*
- 3. **Duration of this Contract.** This contract shall endure in perpetuity unless nullified by either of the following: (1) the agreement of both parties or (2) the permanent destruction of the soul of either party.*
- 4. **Fairness in Infernal Bargains Compliance.** This contract is in compliance with the legal requirements of the Fairness in Infernal Bargains Act of 1218.*
- 5.1. **Advisement of Legal Counsel.** The mortal signee acknowledges that he, she, or it has been advised to seek the legal counsel from a practitioner licensed in Infernal law prior to signing this contract.*
- 5.2. **Amendment.** This contract may not be amended except by written agreement of the parties.*
- 5.3. **Applicable Law.** Infernal law shall govern construction of this contract.*



**5.4. Entire Agreement.** *All existing agreements and contracts, both verbal and written, between the parties are superseded by this contract.*

**5.5. Jurisdiction.** *The courts of the Nine Hells shall have jurisdiction over disputes arising from this contract.*

**5.6 Notice of Possible Translation Errors.** *This document magically translates itself into the reader's native language. Its original language is penned in the Stygian dialect of Infernal. Though great care has been taken to ensure the closest possible translation to the reader's native language, translation errors are possible. In the event of a dispute, the mortal signee agrees that the meaning and intent of this contract shall be construed with its original language.*

**5.7. Notice of Substantial Risk.** *The mortal signee is hereby explicitly warned that entering into a deal with an infernal being is an inherently risky act. The mortal signee assumes risk for any and all intended or unintended consequences of entering into this agreement, including but not limited to moral enfeeblement, spiritual disintegration, and the gradual erosion or sudden annihilation of one's free will.*

**5.8. Paragraph Headings.** *The headings used at the beginning of each numbered paragraph in this contract are not intended to have any legal effect; the headings do not limit or expand the meaning of the paragraphs that follow them.*

**5.9. Severability.** *If any provision of this contract is, for any reason, held to be invalid, illegal, or unenforceable, such invalidity, illegality, or unenforceability shall not affect any other provision of the contract. If the soul of any party to this contract is severed, the terms of this contract shall apply to all resulting soul fragments.*
