NEW SECURITY MEASURES IMPLEMENTED

Darringmoor

Following the unholy attack on the Ormocean Church, we wish to assure all the concerned citizens that Saint Farwick the Blessed was unharmed and has announced new security measures to protect the good people of the city. These will be implemented immediately and are detailed later in this broadsheet.

The temple district was rocked by a massive explosion on the morning of the 12th Air, sending people in the nearby market square into a panic. However, the quick actions of our beloved Bishop saved the day, minimizing damage and establishing security across the city to prevent any further attacks. The paladin orders of the Ormocean and Sirtar Church have been mobilized to lend direct support to the city guard and have taken up posts at key strategic points across Darringmoor. They will remain on alert until the current crisis is deemed to have been contained. The city gates and harbour have been closed and entry and egress to Darringmoor restricted. All persons and wagons passing through the gates will be subject to being searched.

EMERGENCY LAWS EFFECTIVE IMMEDIATELY

1. The Holy Trinity Compound is sealed. Admittance is by formal petition to be made only to the Captain of the Guard at the Trinity Square Gates.
2. Item 1 includes the public harbor-side street entrance to the Esmian Healing Halls.
3. All major gates will close at sundown and reopen at sunrise. All persons and wagons seeking entry to the city will be searched. Non-compliance will result in immediate detention.
4. The harbour will be restricted to all civilians. Merchants wishing to unload or load cargo must obtain permission and papers from the Harbour Iusticator at the Hall of Waterman and Lighterman.
5. All citizens are to follow directions of the Holy Knights who will have posts across the city. There will be no exceptions.
6. A curfew is in place for all travel between the hours of sundown and sunrise and all inns and places of business will cease activity during that time.

COURT OF SHADOWS REPORT

PREVIOUS RESTRICTIONS

Reporting

Any strange occurrences are to be reported immediately to the **Shadow Task Force** which has a clearly marked booth in the Darringmoor Holy Markets. In particular, people acting peculiarly, suspicious barrels, and strange lights. Further investigations of this information will be followed up by the newly formed **Shadow Task Force** office in the Holy Market Compound. Failure to report will be an admission of guilt and those accused will face the **Court of Shadows**.

Missing people are to be continued to be reported to the **Missing Persons** section of the city guards as previously. Failure to do so will be an admission of guilt and those accused will face the **Court of Shadows**.

Time and date of flashes of **Esmian Wedding Jars** must be recorded and immediately taken to the **Shadow Task Force**. Failure to do so will be an admission of guilt and those accused will face the **Court of Shadows**.

Controlled Items

Embalming chemicals are now controlled items. Any sale of such has to be reported. Failure to do so will be an admission of guilt and those accused will face a **Court of Shadows**. The **Shadow Task**

Force will be visiting those business dependent on these chemicals to record and track their use.

All necromantic magic must be handed in by the end of the **March of Fire**. During this time there will be an amnesty. After this time anyone caught with said items will be admitting guilt and will face the **Court of Shadows**.

Restricted Areas

The Darringmoor Cemetery is out of bounds except for sanctioned burials and will be screened by a specialist team of the **Shadow Task Force** in the coming days. Failure to stay out of such restricted areas will be an admission of guilt and those accused will face a **Court of Shadows**. Anyone caught underground without authorization will immediately face prosecution by the **Court of Shadows**.

NEW RESTRICTIONS

Travel and Movement

Travellers moving in and out of the city (citizens or other) will be screened at both ports and city gates. For those whose travel is essential for business, you may, upon approval, be given travel passes, but must carry these at all times on their person and submit to regular screening. Allow extra time when travelling. Anyone failing to adhere to these restrictions will immediately face prosecution by the **Court of Shadows**.

Sedition

Deliberate undermining of lawful authorities through sabotage of new **Shadow Court** policy or of its members by negative verbal or physical actions will face prosecution by the **Court of Shadows**.

Controlled Items

Total ban on possession of amber and mysteria oil. They are controlled substances and must be handed in as soon as possible. Any sale of such must be reported. Failure to do so will be an admission of guilt and those accused will face a **Court of Shadows**.

Be Ever Vigilant

Undead pose a direct and ongoing threat to the safety and wellbeing of Darringmoor citizens and populous of the surrounding area in Sard, Elkia and Llan. The current Undead threat is unprecedented in recent. **Farwick's Counter-Undead Plan** outlines the arrangements, governance and operational responsibilities of all Darringmoor citizens, governments and agencies engaged in countering the Undead threat.

Strategy for Protecting Crowded Places from Terrorism

Crowded places such as markets, docks, and major events will continue to be attractive targets for undead attacks. Darringmoor is not immune after **Blacklight Day**. The objective of **Farwick's Counter Undead Plan** is to protect the lives of people working in, using, and visiting crowded places by making these places more resilient to attacks by **Sirrieth's Minions**.

Compensation

In the **March of Air** the Darringmoor Ormocean Church will provide financial assistance to people affected by **Blacklight Day**. The **Darringmoor Victim of Undead Payment (DVUP)** will be a one-off payment of up to one gold trade and will provide financial assistance for Darringmoor residents who are harmed as a direct result of defending the city from the undead incursion. Payment may be shared among eligible close family members of someone that died as a direct result of this undead incursion. Proof of defence is required for payment. Contact the Ormocean Church if you meet the requirements.

Know Your Enemy

For an effective counter-undead regime, it is vital that laws target not only undead acts, but also the organisations that plan, finance and carry out such acts. Under Ormocean Law, amendment R5437, there are two ways for an organisation to be identified as an undead organisation. Reasonable doubt has been proven that an organisation is a undead organisation offence. Alternatively, the organisation may be specified in Regulations as an undead organisation. This process, known as 'listing'. For more information on the process

and requirements that apply to the listing of undead organisations, see the Ormocean Church.

Currently, 5 organisations are listed as undead organisations under the Ormocean Law. They are:

- **Sirrieth Church**
- **Elly Tinker and associates**
- **Cult of the Blackened Skull**
- **Order of the Shadows**
- **Companions of the Twisted Bones**

Elements of the Plan

What are we doing?

In this section:

• **Ormocean Information Stalls**—is the single point of contact for the public to report possible signs of undead.

• **Laws to Combat Undead**—The Ormocean church has a very extensive range of legislation around counter-undead, national security and related offences.

• **Undead Task Force**—is made up of representatives from the Holy Trinity, Darringmoor Council, Major and guild leaders. This force's goal is to strengthen cooperation, collaboration and build capability to counter undead incursions.

• **Declared Area Offence**—information about the offence of entering, or remaining in, a declared area where a listed undead organisation is engaging in a hostile activity.

He commented, We will surely miss **Lily** for her devotion to the Tas and the loss of what she may have become – and for her mischievous smile!

Aedrinna Pellidon, who is visiting the **Elven Enclave** in Darringmoor, has announced that an annual stipend will be established by the **College of Arcane Science** to assist potential **Wizards** from poorer families to study with the **Guild of the Magi**, in recognition of **Lilly's** own circumstances.

MEMORIAL PROJECT UNVEILED

ONE hundred men from Darringmoor who died during **Blacklight Day** are to be remembered in six new memorials. The six, 7 foot high plaques will be erected at regular intervals along the **Holy Trinity** wall during the next year. Installing the plaques will begin a memorial project initiated by the city council to honour the ordinary citizens who defended our fair city. The committee comprised **Siritar paladins**, **Church representatives**, the city guard, guild members and the **Mayor**. This project plans to employ masons to chisel and mount plaques at regular intervals along the **Holy Trinity Wall**, where it can be seen by all market attendees. The project will be funded by donations from the Ormocean Church.

OBSERVE & PROTECT

Where does the Ormocean Church Fit?
The Church plays an essential role in the following areas:

- * maintain policies, legislation and plans regarding **Sirrieth, Undead** and the banned cults
- * maintain counter-undead incursion, consequence-management capabilities w/in their relevant agencies
- * has primary operational responsibility for responding to a **Sirrieth** situation in their jurisdiction, under the Act
- * determine prevention strategies and operational responses to threats, including seeking assistance from any other jurisdictions
- * actively consider the requirement for the declaration of a **Sirrieth Situation**

What is a Sirrieth's Minion Act offence?

It is an offence to:

- * commit an act aiding the **Sirrieth church**
- * plan or prepare an act aiding the **Sirrieth church**
- * finance undead incursion or an act aiding the **Sirrieth church**
- * provide or receive training in the cult of **Sirrieth**
- * possess things connected to the **Sirrieth's church** act aiding the **Sirrieth**
- * collect or make documents likely to facilitate **Sirrieth's** minion acts.

LET'S BE CLEAR! It is an offence to:

- be a member of - direct the activities of - recruit for train or receive training from - acquire funds for acquire funds from or to - provide support to a **Sirrieth** organisation.

When can the Justicator, Siritar Paladins or City Guards preventatively detain a person?

The **Justicator, Siritar Paladins or City Guards** of Darringmoor and surrounds can detain people under preventative detention orders, where there is a threat of an imminent undead attack or after an undead attack has occurred. Citizens can be detained if it is necessary to prevent an imminent undead act or if it is likely vital evidence in the aftermath of such an act will be lost. Under Ormocean law, the maximum amount of time a person can be preventatively detained is 148 days.
