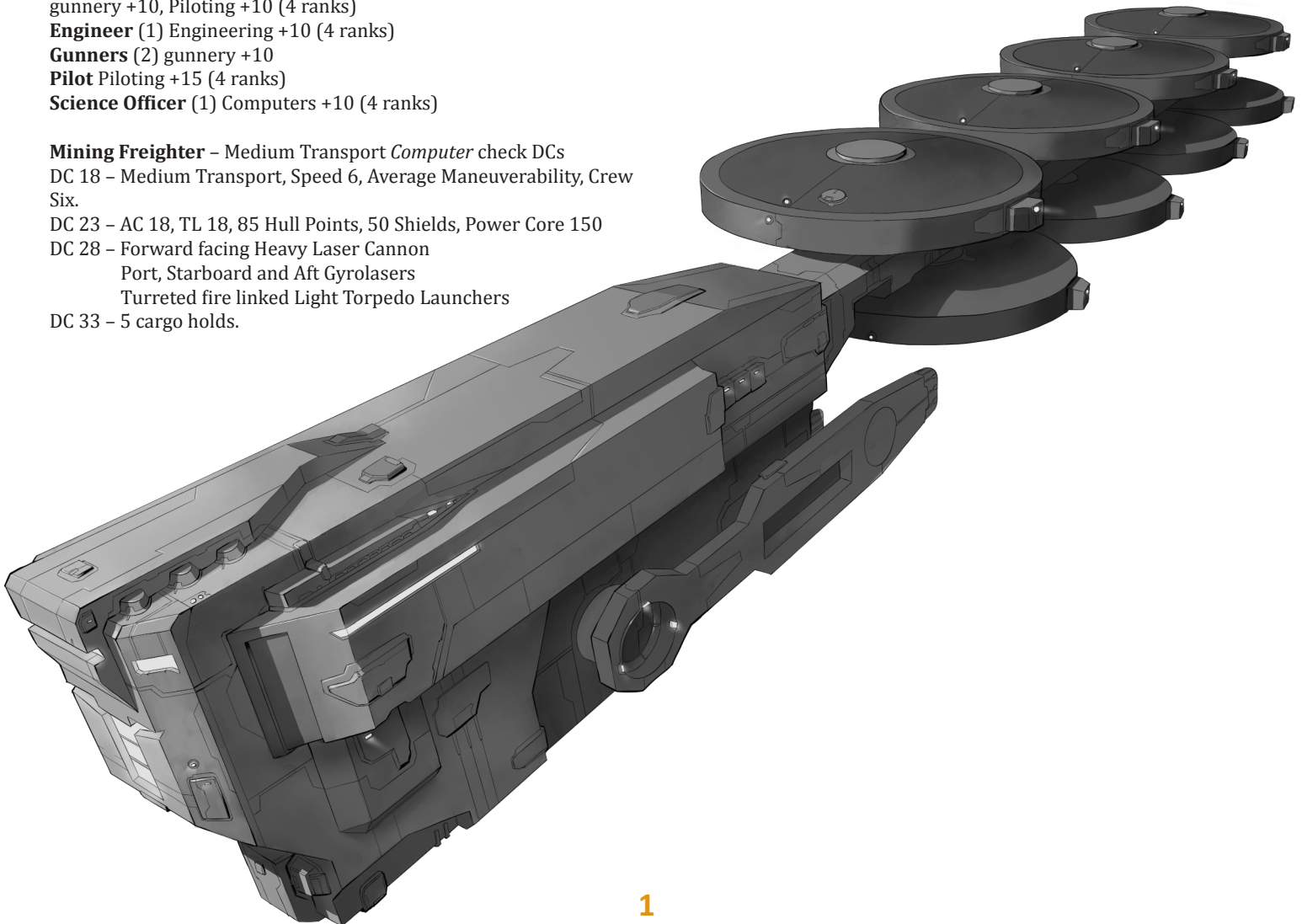

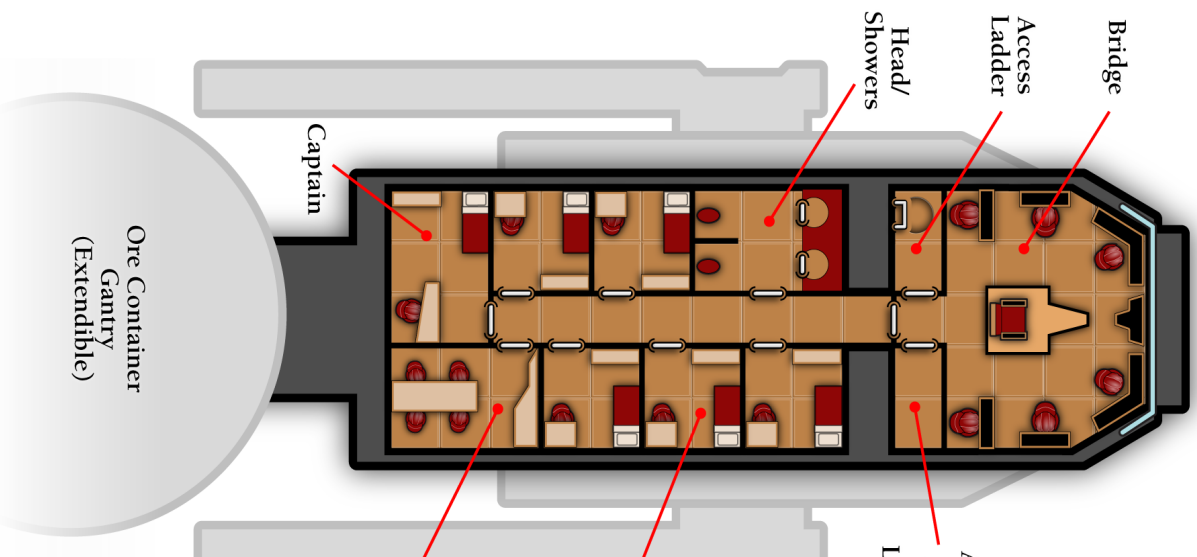
The Katar Mining Freighter does one thing: haul mineral ore from asteroid mines to the factories where it's needed. This freighter, a much larger version of the *Katar Light Freighter, Tier 1*, with similar controls and layout. This similarity means that Light Freighter crews working on small cargo runs can be contracted with short haul ore delivery by a mining concern with little to no retraining time. The defensive systems on this tough ship are capable of making would-be pirates pay for interfering with them: individual mining vessels might be ambushed, but convoys are rarely attacked.

Unlike the Light Freighters, miners such as these aren't often sold to private concerns as they age. Mining Freighters a century old are still in operation, dutifully hauling their cargo on well-established runs. Some of these ships are bought right off the assembly line by non-Katar factions, as the transports have a reputation of being sturdy, reliable ships, even if they aren't the prettiest.

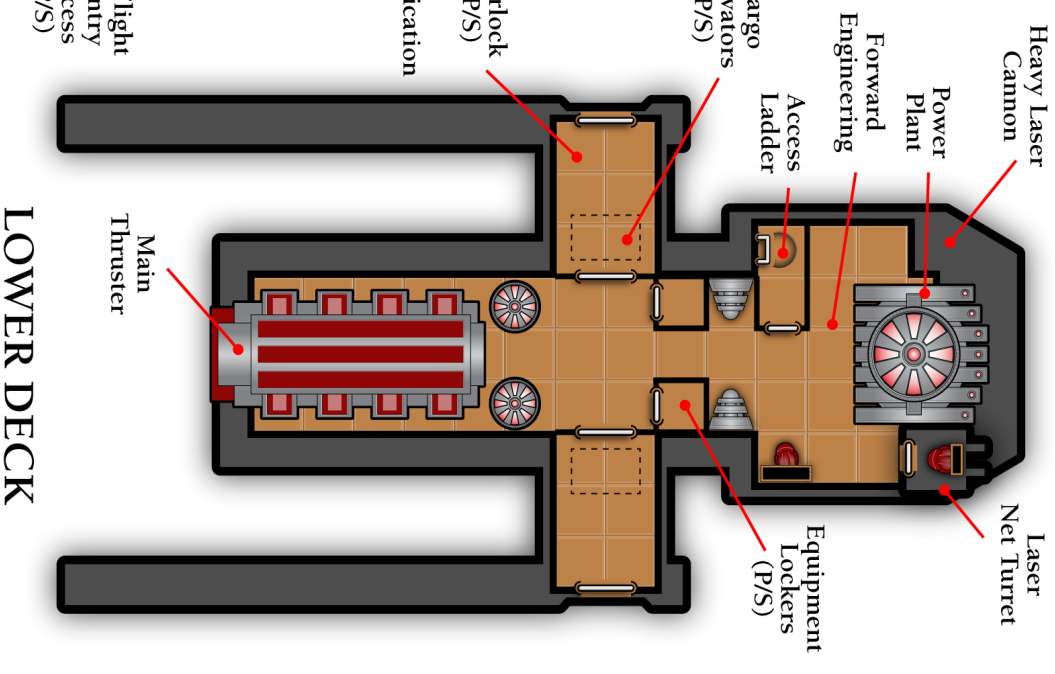
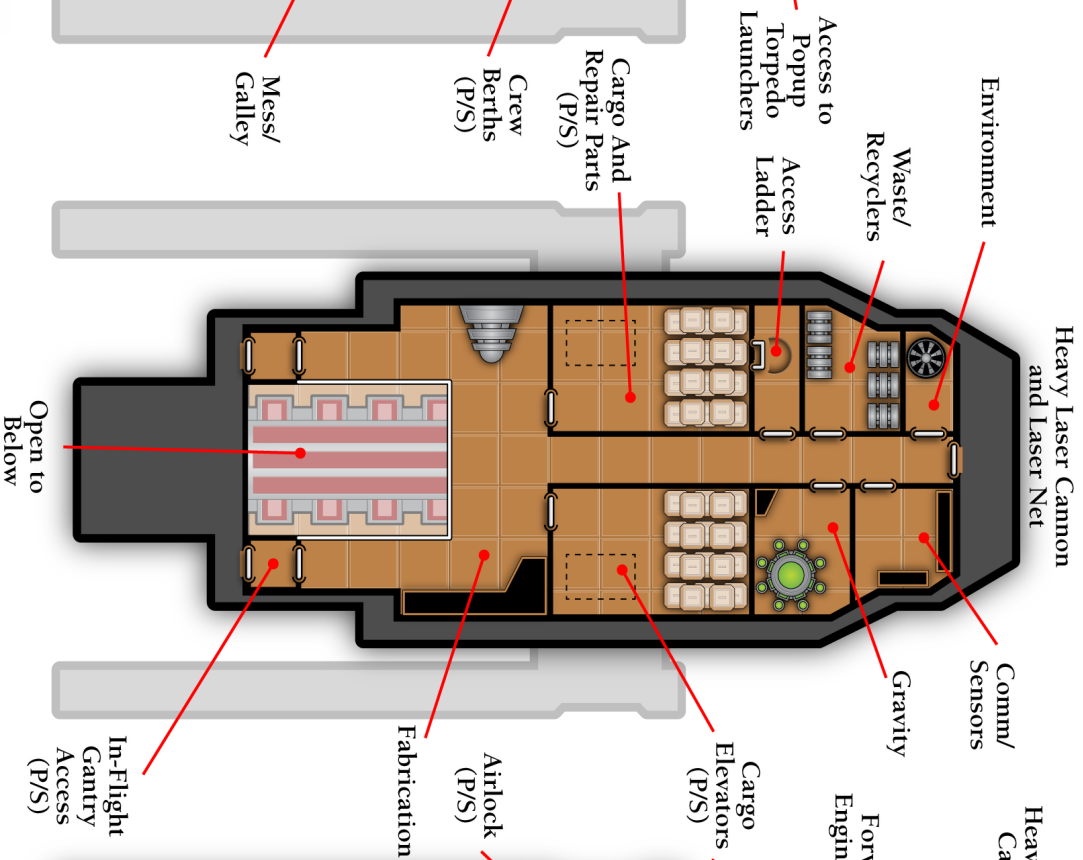


# Katar Ore Freighter
